Boat Lift with Polyethylene Tanks

- ☒ Polyethylene Tanks – For the period of time the original purchaser owns the Boat Lift, provided there has been no alteration to the Boat Lift.
☒ Steel component parts (parts above the water) – 5 years under normal use and service.

Control Unit

- ☒ Two year Limited Warranty.

General Limited Warranty Conditions for All Products

- ☒ All warranties for elements of the Boat Lifts set out above are applicable only for normal use and service in fresh water.
☒ Upon discovery of any defect in material workmanship within the period of Limited Warranty set out above the owner must promptly notify Boat Floater Industries, LLC in writing. Notice to Boat Floater Industries, LLC must be received no later than one month following the expiration of the relevant warranty period.
☒ If any such claim is covered by the Limited Warranty and is timely made, Boat Floater Industries, LLC will correct any defect in material or workmanship with either new or refurbished parts at its sole discretion.
☒ All limited warranty service, at Boat Floater Industries, LLC option, will be performed at our plant in Miami, Oklahoma, or at service centers designated by Boat Floater Industries, LLC, with roundtrip freight charges prepaid by customer to the plant or designated service center. Warranty work or shipment of replacement part will be done within Ninety (90) days from receipt of the failed product or part.
☒ In the event of a product defect, due to material and workmanship, is not repaired after three attempts, then the customer will be given the choice of additional repair or refund of the original purchase price.
☒ Any disputes concerning this warranty are to be resolved via arbitration in Miami, Oklahoma.
☒ EXCLUSIONS from limited Warranty; (i) labor costs; (ii) any products, parts not manufactured by Boat Floater Industries, LLC; (iii) installation of the product; (iv) defects or damage and any shortened life of product caused by inappropriate installation of product; (v) use of boat lift for any purpose for which product was not designed and any abuse or misuse of the product; (vi) modification of product by customer or unauthorized attachments or use; (vii) damage from shipment of the product; (viii) damage caused by any misuse or abuse of the product; and (ix) any damage caused by product being used in any medium that is not fresh water.
☒ The repair or replacement of parts are the exclusive remedies for breach of any warranty and Boat Floater Industries, LLC will not be liable for any consequential damages.
☒ This Limited Warranty is extended to the original purchaser of the products only and is limited to defects in material and workmanship.

#### To Lower Lift

- ☒ Move BLACK control handle(s) to RAISE/LOWER and RED handle to LOWER. This moves the valves to the open position.
- ☒ Leave handles in LOWER position until the lift is in the full down position. (The top of the guide arms are on rollers and the boat is floating free).
- ☒ Move all handles to hold position

#### To Raise Lift

- ☒ First makes sure boat is properly positioned on lift. If you have tie lines from the guide arm to the rear cleats of your boat this can be easily achieved by applying back pressure to the boat making the lines tight. Normally the transom of boat should be even with or slightly forward (within 4") of the end of the main support bunks.
- ☒ Move only the BLACK control handle(s) to the RAISE LOWER position, leaving the RED handle in the HOLD position. LOWER ONLY is for LOWERING ONLY.
- ☒ Turn blower switch on.
- ☒ When the lift is in the Raised position, (note: guide arms are firmly seated against the rollers), Turn the blower switch off and move the BLACK control handle(s) to the HOLD position.

CAUTION: If the Black control handle is left in the RAISE/LOWER position and the blower switch remains on for a long period after the rollers are firmly seated, damage may result to the lift, dock or both due to over inflation of the lift tanks.

1. Should your lift not raise or lower in a level position, or if there is any presence of binding, turn all handles to the HOLD position and blower switch off and contact your authorized Boat Floater Industries, LLC Dealer for service.

#### ADDITIONAL INFORMATION

- ☒ When your Boat Floater Lift is not in use it should be in the up position. This is very important as damage may result if the lift is left in the down position for a prolonged period of time, especially with rough water conditions.
- ☒ Your Boat Floater Lift requires a minimum of maintenance. We suggest you periodically check all the nuts and bolts to insure they are tight.
- ☒ Boat Floater Industries, LLC suggests always using Boat Floater Industries, LLC parts and Authorized Boat Floater Industries, LLC Service for your Boat Floater Lift.
